**Announcement  
Trading Update  
Power Generation For November 2025**

This announcement is made by CGN New Energy Holdings Co., Ltd. (the “**Company**”) on a voluntary basis.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the “**Group**”) on a consolidated basis amounted to 1,746.4GWh for the month of November 2025, representing an increase of 28.3% compared with the corresponding period of 2024. In particular, power generation of PRC wind projects increased by 14.1%, power generation of PRC solar projects increased by 66.5%, power generation of PRC hydro projects decreased by 7.1% and power generation of Korea projects increased by 52.1%. For the eleven months ended 30 November 2025, the accumulated power generation of the Group amounted to 17,499.8GWh, representing a decrease of 1.0% compared with the corresponding period of 2024. In particular, power generation of PRC wind projects decreased by 1.4%, power generation of PRC solar projects increased by 30.4%, power generation of PRC gas-fired projects increased by 9.4%, power generation of PRC hydro projects decreased by 10.5% and power generation of Korea projects decreased by 7.5%.

<sup>1</sup>: In November 2025, average wind speeds increased year-on-year across most provinces and regions where the onshore wind power projects of the Company operate, resulting in a year-on-year increase in power generation for November 2025.

<sup>2</sup>: In November 2025, the capacity of the Company's solar projects increased year-on-year as compared to November 2024, resulting in a year-on-year increase in power generation in November 2025.

<sup>3</sup>: The Company's Yulchon gas-fired projects in Korea experienced a significant increase in dispatch power in November 2025, resulting in a year-on-year increase in power generation in November 2025.
